



MINOR PARTICIPATION WAIVER

Release of Liability, Acknowledgement and
Acceptance or Risk, & Consent

PLEASE READ CAREFULLY BEFORE SIGNING

In consideration of the enrollment of the Child in one or more programs (the "Program") in VanWest College ("VanWest"), \$1.00 and other good and valuable consideration, at my request I, the parent or guardian of the Child, for myself and for and on behalf of the Child, do hereby:

1. Voluntary Participation – agree that I have voluntarily permitted the Child to participate in the Program;
2. Child's Ability and Behaviour – represent to VanWest that the Child is mentally and physically able to participate in the Program and agree that if the Child's behaviour is, in the sole judgment of the Vanwest, disruptive or inappropriate the Child may be expelled from the Program;
3. Medical Treatment – agree that in the event of the Child's illness or injury during a Program any of the Releasees may seek emergency and medical treatment or other appropriate assistance and that I will be responsible for any medical or other charges in connection with such treatment or assistance. I agree to have adequate medical insurance coverage for the Child during the period of the Program;
4. Waiver and Release – waive any and all claims that I or the Child may have, from time to time, against VanWest and their respective officers, directors, governors, commissioners, employees, contractors, successors and assignors (collectively, the "Releasees") and each of them, and release the Releasees and each of them from any and all liability for any loss, damage, expense or injury (including death) that I, my next of kin or the Child may suffer, resulting from the Child's participation in the Program due to any cause whatsoever, including negligence, breach of contract, breach of any statutory duty or other duty of care, including any duty under the Occupiers Liability Act R.S.B.C. 1996 c.337 on the part of any of the Releasees;
5. Indemnity – I agree to indemnify and hold harmless the Releasees and each of them from any and all liability resulting, in whole or in part, from the Child's participation in the Program; and
6. Authority – represent to the Releasees that I am the parent or lawful guardian of the Participant and, as such, have the authority to enter into this document.

I CONFIRM THAT I HAVE READ AND UNDERSTAND THE FOREGOING TERMS AND CONDITIONS PRIOR TO SIGNING THIS FORM AND THAT BY SIGNING THIS FORM I AM WAIVING CERTAIN RIGHTS WHICH I OR THE PARTICIPANT MAY HAVE AGAINST THE RELEASEES.

I ALSO CONFIRM THAT I HAVE DISCUSSED THE ABOVE WITH THE CHILD AND TO THE BEST OF MY KNOWLEDGE THE CHILD UNDERSTANDS THE TERMS AND WHAT IS EXPECTED OF HIM/HER.
